President's Updates

- **Facilities**
 - Attic stairs repair is considered "solid."
 - New night court lighting not yet completed.
- **Cal-Am Leadership Meeting**
 - Awaiting contact list from Tyler (Cal-Am) for inter-park coordinator/leadership roundtable.
- **Balls & Supplies**
 - Proposal to request Cal-Am/Mesa Regal supply pickleballs this season as a trial.
 - Brand/quality (X-40 vs alternatives) to be evaluated; cheaper balls may be used for training.
 - Inquiry to include what else Cal-Am will supply (e.g., ball machine).
- **APPL / Leagues**
 - Limited interest so far (one women's 3.5 team request).
 - Fewer APPL teams anticipated if Cal-Am "league program" moves forward.

Treasurer's Report

- **Balance: ~\$14,095.76 after \$99 GoDaddy expense.**
- **Upcoming Expense: Another GoDaddy invoice (\$203) pending.**
- **Revenue: Tournament income starts Oct. 1. Monthly socials budgeted with emphasis on member value.**

CourtReserve / Registration

- **Registration system is open and functioning smoothly.**
- **Newsletter distribution successful.**
- **Dropdowns now clarify three membership types.**
- **Communication: Kevin will post on Facebook that registration is open and direct members to the MRPC site for CourtReserve access.**

Programs & Schedule (≈95% complete)

- **Adjustments:**
 - **70+ program shifted to Wednesday morning for added court capacity.**
 - **Another high-demand midweek program also moved to Wednesday morning.**
 - **New 3.75 Ladies anchored on Wednesdays.**
- **Coordinator Change:**
 - **Tuesday night 3.0–3.99 Mixed RR taken by David Quon.**
- **New Proposals:**
 - **Skinny Singles (Brian Menninger).**
 - **Singles Social (Cal Herle): Requesting 3 courts, late afternoon, grouped by skill.**
 - **Board approved limited off-peak singles trials, with review before January.**
- **Inter-Park Coordination:**
 - **Greater schedule alignment across parks identified as key priority for upcoming Cal-Am meeting.**

Policy Decision (Unanimous)

- **CourtReserve Exemption Request: Denied.**
 - **Rationale: Ensures fairness, consistent court allocation, accurate participation data, and eligibility verification.**
