1) Approval of Minutes

- **Minutes of the October 13, 2025 meeting were approved as presented.**

2) Treasurer's Report

- **MRPC's fiscal year runs from March 31, 2024 to March 31, 2025.**
 - **Darlene requested someone review the 2024–25 books; Kevin agreed to complete the review.**
 - **The Board reaffirmed the long-standing policy not to post the club's budget balance in public-facing minutes. Financial records remain open to all members, but balances will not be shared publicly. Expenditures will continue to be included.**
 - **Action: Smith will remove budget balances from posted minutes.**
 - **The budget was reviewed. The club expects a loss of approximately \$575 related to refunding tournament entry fees for the canceled Steve Judy Tournament due to Pickleball Brackets non-refundable processing fees.**

3) President's Report

- **Recap of First Social: The event was well attended and enjoyable. Reggie thanked everyone who helped make it a success.**
- **Cohort Consortium Meeting: The proposed meeting was canceled due to low response. The Board hopes Interpark contacts will help revive interest. Kevin will obtain the contact list from the Interpark Coordinator.**

- **Interpark Schedule:** The schedule has not yet been finalized, as many parks are still planning their calendars. A meeting is anticipated soon. Interpark DUPR is a new offering this year.
 - **Canceled Steve Judy Tournament:** Due to low registration, the Tournament Chair recommended cancellation. The Board concurred.
 - **PA System:** After comparing the tournament PA system to the cost of purchasing a new one, the Board agreed to use the tournament system at the next social as a trial.
 - **Ball Supply:** Allison will evaluate whether additional balls need to be purchased.
 - **Flooding of Palo Verde Building:** Many historical Executive Board records were destroyed in the recent flood. Records from 2019 have been preserved on a thumb drive (thank you, Marcie).

Additional Business

- **Cal-Am League:** Cal was thanked for organizing the effort. At this time, there is not enough interest to move forward.
 - **Pro-Cert Ratings:** Allison will try to arrange on-site testing opportunities for members at Mesa Regal.
 - **Manager Special:** The club was asked to assist with serving at the Managers Special event. Reggie will meet with Tyler to determine volunteer needs and will post a sign-up afterward.
 - **CPR/AED Training:** A four-hour certification course will be offered in January (date TBD). Cost is \$45 per participant.
 - **Facebook Page:** Membership in MRPC is required to join the page. Darlene will continue to monitor.
 - **Ball Machine:** While the schedule could be added to CourtReserve, it would limit availability. Allison, Ball Machine Coordinator, prefers the current open-access guidelines.
 - **Live Streaming:** Further discussion with management is needed. The club is not in a position to monitor livestreaming at this time.
 - **Ratings:** Discussion tabled until the next meeting.
